NOTICE INVITING BID

College of Vocational Studies invites GeM bid for purchase of 25 projectors, etc. from authorized distributors/dealers for supply and installation at site within three days of the issue of work order. Tender documents may be downloaded from College and University of Delhi Website i.e. www.cvs.edu.in & www.du.ac.in respectively.

General Terms and Condition:

1. Bid submission: bids shall be submitted online only at **GeM Portal**.
2. Not more than one tender shall be submitted by one supplier having business relationship. Under no circumstance will father and his son(s)/ Daughter(s) or other close relations who have business relationship with one another (i.e. when one or more partner(s)/director(s) are common) be allowed to tender for the same contract as separate competitors. A breach of this condition will render the tenders of both parties liable to rejection.
3. Bidder who downloaded the tender from the college website www.cvs.edu.in **shall not tamper / modify the tender form including downloaded price bid template in any manner**. In case if the same is found to be tampered/modified in any manner, tender will be completely rejected and tenderer is liable to be black listed from doing business with the College/University of Delhi.
4. **Intending tenderers are advised to keep checking the college website cvs.edu.in regularly till closing date of submission** of tender for any corrigendum / addendum / Amendment.
5. The college has the right at any time, by written notice, in the form of an amendment order, increase or decrease quantity to make any changes it seems necessary, including changes in specification etc.
6. The college right to increase or decrease the quantity to be ordered as per rules
7. 100 % payment shall be released upon successful commissioning of the equipment/ item on showing documents of installation or takeover.
8. Sub-Standard material will not be accepted and the same shall be removed by the supplier at his own cost.
9. TDS will be deducted as per rules.
10. In case of award of contract/order all items will have to be delivered at the College within prescribed time.
11. Payment will be made through RTGS/NEFT/Bank Transfer Mode only after installation of the Computers.
12. The College reserves right to accept/reject/amend the tender/bid in part or full without assigning any reason thereof.
13. The price shall be quoted in Indian rupees only.
14. Technical bid and financial bid should be provided in two separate bids. The financial bid of those Vendors/Bidders will be opened who qualify technically.

Warranty

1. The bidder shall offer on-site comprehensive warranty of all the items for three years from the date of successful installation of all the items at the designated location and shall cover each and every part of all the items. The purchaser is not liable pay any extra charges on any account during warranty period.
2. The bidder will not charge any extra charges on any account during warranty period.
3. If any part or parts fails / proves defective within the on-site warranty period specified above, owing to defect in design, material or workmanship, the bidder shall have to replace them at the earliest, but not later than 15 days.
4. During the warranty period, experts shall be deputed at site by the bidder within three working days from the date of request from purchaser, to rectify and fix the defects of all desktops computers at the location supplied.

Terms and conditions (Technical)

1. OEM/Bidder participating in the Bid must have Company Registration Certificates required
2. OEM/Bidder majority shareholding must be owned by people of Indian origin. AND/OR OEM must not have any shareholding from any country that shares the border with India Company Registration Certificates must be uploaded.
3. OEM/Bidder must have proven track record of supplying of IT Equipment's /Projector PO copies must be uploaded
4. For support attached declaration with SLA that the Bidder/OEM participating in the bid must have service centre Pan India and Toll free no. in the support attached declaration with SLA.
5. Attached certificates with this for OEM must have certification from BIS, ISO 9001, and must have ISO 27001 for Data Security compliance for the product.
6. Declaration on Letterhead that the Bidder/OEM participating in the bid must not have been blacklisted for fraudulent practices by any Central Government / State Government / Central PSU/ State PSU/ Government Undertakings / University/ Educational Institutions in India in the last three years and at the time of submission of the bid.
7. It is the condition of the tender that the items should be supplied and installed within 3 days after the Award of Contract.
8. The tenderer reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid/ tender quantity at the time of placement of contract. The tenderer also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.
9. Bidder should have bank solvency certificate.

11. Bidder Should have established office in Delhi /NCR.
